



Campaign Finance Duties of National Association of Secretaries of State (NASS) Members

March 2, 2010

This document provides an overview of campaign finance information filed with the 22 NASS member offices that have campaign finance responsibilities.* Links are provided to the state websites that allow public viewing of campaign finance reports. The information is based on a February 2010 review of campaign finance resources available on Secretary of State websites and is subject to change. This is not an exhaustive list of every campaign finance form/document filed with the office. The precise definitions of different political committees/entities and the content of campaign finance forms may vary by state. This information is not intended to serve as a reference for individuals or entities seeking guidance on the appropriate forms to file.
