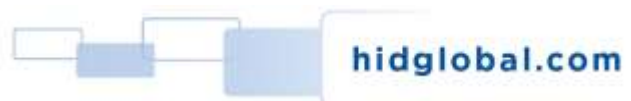
Dear Remote Notarization Task Force:

Advancements in technology have proven to simplify transactions that consumers conduct to manage their daily lives. Many of these routine functions have transitioned to an electronic format, such as the remote eNotary process. Remote notarization creates a more efficient and accessible process for consumers to utilize in the comfort of their own homes and according to their schedule. Similarly, businesses can rely on the authenticity of documents through the use of digital identity credentials, which deliver a verifiable form of notarization with nonrepudiation and a digital audit trail.

IdenTrust (a part of HID Global) TrustID digital identity credentials guarantee the identity of people and their business affiliation online.
