Summary of Information Collected from Corporations and LLCs December 2024

Business formation documents, periodic reports, and other business filings are filed with the Secretary of State (in 40 states) or another state agency. This chart provides an overview of the information that each state requires domestic corporations (for-profit) and LLCs to provide in formation documents and periodic reports. Please note that states may require additional information beyond the basic requirements reflected in the chart depending on the specific type or structure of a corporation or LLC.

Corporations

Formation Documents

All states require corporations to file a formation document with the state filing office (often referred to as the Articles of Incorporation). The specific information required in formation documents for corporations varies by state, but often includes: the corporation's name, purpose, and principal office address; the name and address of the corporation's registered agent; the name and address of the incorporator(s); and the number of authorized shares. Fifteen states require the names and addresses of any initial officers and/or directors in formation documents.

Periodic Reports

Forty-five states and the District of Columbia require corporations to file a periodic report or similar document. Thirty-eight of these states require the report to be filed annually, and 7 states and the District of Columbia require the report to be filed biennally. Periodic reports for corporations (where required) generally require similar information as formation documents, and nearly all periodic reports require the name and address of officers and/or directors.

Other Information Required

Some states require corporations to include additional information in formation documents and/or periodic reports. For example:

- Alaska requires the articles of incorporation and biennial reports to include information on any foreign individuals or entities that control, or are controlled by, an Alaska corporation (alien affiliates)
- Arizona requires the articles of incorporation and annual reports to include a certificate of disclosure (information on felonies/judgements and bankruptcy) for officers, directors, certain shareholders, and other individuals
- Kansas requires biennial reports to include the names of any entities (registered in the state) in which the corporation holds more than 50% equity ownership
- Oregon requires the articles of incorporation to include the name and address of an individual with direct knowlege of the corporation's operations and business activities
- Washington D.C. requires the articles of incorporation and biennial reports to include the name and address of individuals whose legal or beneficial ownership exceeds 10%, or have control over the corporation
- West Virginia requires annual reports to include information on any parent corporation, and any subsidiary corporation in the state
- Arkansas, Delaware, Maryland, and Wyoming require periodic reports to include information on property and assets for tax purposes. Illinois requires that information in certain circumstances.

LLCs

Formation Documents

All states require LLCs file a formation document with the state filing office (often referred to as the Articles of Organization or Certificate of Organization). The specific information required in formation documents for LLCs varies by state, but often includes: the LLC's name, purpose, and principal office address; the name and address of the LLC's registered agent; and the name and address of the organizor(s). Fourteen states require the name and address of members and/or managers in formation documents.

Periodic Reports

Forty-one states and the District of Columbia require LLCs to file a periodic report or similar document. Thirty-five of these state require the report to be filed annually, and 6 states and the District of Columbia require the report to be filed biennially. Periodic reports generally require similar information as formation documents, and 30 states require the name and address of managers and/or members.

Other Information Required

Some states require LLCs to provide additional information in formation documents and/or periodic reports. For example:

- Alaska requires biennial reports to include the name and address of anyone owning at least 5% of shares
- New York (effective January 1st, 2026) will require the certificate of incorporation to disclose any beneficial owners (including identifying information)
- Oregon requires the articles of organization to include the name and address of an individual with direct knowlege of the LLC's operations and business activities
- Washington D.C. requires the articles of organization and biennial reports to include the name and address of individuals whose legal or beneficial ownership exceeds 10%, or have control over the LLC

- Maryland and Wyoming require annual reports to include information on property and assets for tax purposes
